Please note: Only assessments and/or consultations may be covered up to grid maximum each calendar year. Medications/treatments provided or prescribed by a Naturopathic Doctor cannot be reimbursed.

Providers shall charge the lesser of the rate charged by the provider to any patient paying cash for the same service/product, up to the maximum rate contained in the benefit grids.

Naturopathic Doctors who are providing services in a regulated province and/or territory* must meet the following criteria:

 Providers must be registered members in good standing and have an unrestricted license/registration in the province/territory in which they are practicing.

NOTE: Naturopathic Doctors in regulated provinces/territories are not required to be a member with the Canadian Association of Naturopathic Doctors (CAND).

*The six regulated provinces and territories are:

- Alberta
- o British Columbia
- Manitoba
- Ontario
- Saskatchewan
- Northwest Territories





Naturopathic Doctors who are providing services in an unregulated province or territory must meet the following criteria:

- Nova Scotia: As per the applicable Legislation, providers in Nova Scotia must be
 registered members in good standing with an unrestricted license/registration in a
 regulated province or territory and be a member in good standing with the Nova Scotia
 Association of Naturopathic Doctors (NSAND) and the Canadian Association of
 Naturopathic Doctors (CAND).
- All other providers must be members in good standing with the Canadian Association of Naturopathic Doctors (CAND).
